PUBLIC NOTICE

Whereas online recruitment applications for **312 posts of Assistant Staff Nurse** were invited w.e.f. **12.12.2025 to 16.01.2026** vide **Advertisement No. 07/2025** dated 06.12.2025.

Whereas in the ibid advertisement, **the minimum and maximum age** limit to be reckoned as on 01.01.2025, was **21 years and 32 years** respectively.

Whereas the matter was **subjudice before the Hon'ble High Court of HP in the matter of Amita vs State of HP & others in CWP No. 274 of 2026** with respect to maximum age for entering the services as well as age relaxation to the reserved categories.

Whereas the Hon'ble High Court of HP in the ibid matter, directed that the applications in pursuance to Advertisement No. 07 of 2025, may be continued to be accepted, however, further process shall be **kept in abeyance till next date**.

Whereas the Secretary (Health) to the Govt. of HP vide their letter No. HFW-B-A-04/5/2025 dated 24.03.2025 intimated that as per the direction of Hon'ble High Court in CWP No. 274/2026 titled as Amita Vs State of HP & ors, the Government of HP **has decided to extend the date of applications to apply for vacancies of Assistant Staff Nurse Post Code-25026 for further 10 days alongwith adopting the maximum age limit to appoint incumbents to this post with the maximum age limit of 45 years alongwith 05 years age relaxation for SC/ST and other categories**.

Now, therefore, in order to provide **equal opportunity to candidates possessing the age limit criteria**, it has been decided by the Aayog to **revive Advertisement No. 07/2025** for a further period of **14 days, from 31.03.2026 at 10:00 A.M. to 13.04.2026 up to 11:59 P.M.**

Accordingly, **eligible and desirous candidates** are advised to apply online well in advance to avoid any last-minute rush during the closing dates of submission of the Online Recruitment Application.
